Supervision Corner: I'll Take My Therapy To-Go, **Please**

Breaking down barriers and increasing social mobility is something a typical social worker does with individuals, families, and communities on a regular basis, but for the social workers themselves, social mobility while practicing in the field comes with a significant barrier. When a fresh and excited social worker graduates from a nationally-accredited (i.e., the Council for Social Work Education) program and passes the Association for Social Work Boards clinical examination, they then contact the state in which they want to practice social work to apply for a license and complete any other paperwork the state may require. Where the barrier lies is that each state has its own requirements in order to obtain a license to practice social work in that state. This means a social worker may only "do" social work in the states they are licensed in thus limiting their ability to offer their services throughout their career. What this looks like in reality is social workers facing unnecessary barriers or needing to start the licensure process over entirely for moving out of state, being inaccessible to clients when out of the state in which a license is held, and limiting the support available to areas that are underserved, geographically isolated or lack specialty care. At this time, the Council of State Governments supports the implementation of a bill (the Model Social Work Compact Bill) that will allow for individual states to "opt-in" to an agreement that allows social workers to practice within any of those states regardless of where they obtained their license to practice.
